## **School Speech and Language Therapy Packages**

### **Gold Service Package: £350 per day (9-5pm)**

This will include:

- Up to 5 students seen per day for 1:1, 30- 45-minute therapy sessions by a Speech and Language Therapist (SLT).
- SLT support to set up language, speech or phonology groups (as appropriate) run by school staff, to continue in-between SLT visits.
- Training for teaching and support staff to support students within the classroom.

### **Silver Service Package: £300 per day (9-5pm)**

This will include:

- Up to 5 students seen per day for 1:1, 30 - 45-minute sessions by a Speech and Language Therapist (SLT), including standardised assessment, ongoing therapy and administration.
- Training for teaching and support staff to support students within the classroom.

### **Bronze Service Package: £275 per day (9-5pm)**

This will include:

- Up to 5 students seen per day for 1:1, 30 - 45-minute assessment sessions.
- Brief, written recommendations (200 words), provided to teachers and support staff.

### **This will include:**

- A qualified, HCPC registered, SLT being assigned to each school, who will integrate within the school team.
- All staff are enhanced DBS checked with DBS update service.
- All staff are fully insured.
- Regular clinical supervision for the SLT from a Highly Specialist Speech and Language Therapist from the wider SLT team.
- Cover from the wider Speech and Language Therapy team if required and possible for sickness, annual leave etc.
- GDPR compliant administration software and laptop for SLT to use.
- Standardised assessments and resources for SLT to use.
- Castlepoint Independent Speech and Language Therapy has strong links with Essex University and often provides placements to Speech and Language Therapy students. A school contract would benefit from student input as well as clinician input during times of placements.
- Advice on screening tools being used to refer students to Speech and Language Therapy.

### **Requirements:**

- A designated, quiet, and private space will be required for all Speech and Language Therapy work and administration to be carried out in each school. Access to WIFI is essential.
- School staff will be prepared with a time for student sessions and students should be available and ready for their allocated session. If they are not, this will affect the SLT's ability to carry out the designated sessions for the specified 45 minutes.
